Prevention and Recovery in CFISD: Project 98/Project 98 No Show

- Project 98 & Project 98/No Show are dropout recovery initiatives designed to help campuses recover students who have withdrawn from school with a Leaver Code 98.
 - This code is used for students who are withdrawn by the school district after a period of time because they have quit attending school and their reason for leaving is not known. It is also used for students who withdrew from/left school for reasons not listed above
 Leaver Code 98 will translate to a dropout in state and federal accountability.
- Registrar, Assistant Principals, and other campus personnel are asked to conduct focused recovery efforts including phone calls, emails and home visits to students were withdrawn with a code of 98 during the previous schoolyear and those who were expected to return for the current school year but did not.
- Reconnecting students before the School Start Window each year is key.

Prevention and Recovery in CFISD: Operation GRADuation & Prevention

- Each campus is asked to work to:
 - Generate campus-based data
 - Review campus-based interventions
 - Authenticate the impact of interventions
 - Develop personalized interventions
- This will be campus-specific, but will include some common elements
 - Attendance Tracking System
 - Truancy Prevention Measures (TPMs) with are reported to the state through the Public
 - Education Information Management System (PEIMS) each spring.
- When a student withdraws there is a tiered plan to help ensure that the student continues their education
 - 2 weeks 2 weeks 1 month
 - Dropout Tracking System

Prevention and Recovery in CFISD: Missing Students Initiative

- Appendix D of the Texas Education Data Standards (TEDS) provides an expanded definition and specific guidelines on acceptable documentation for each of the leaver reason codes:
- In CFISD, a student received a Leaver Code 98 when they withdraw from school.
 - A missing student is a CFISD specific term used to describe a student who was attending class this year, was withdrawn and after 30 school days has maintained the Leaver Code 98.
 - Registrar, Assistant Principals, and other campus personnel will conduct focused dropout recovery efforts including phone calls and emails and other means of contacting the family. They document their efforts in our central tracking system.
- If the school is unsuccessful in their efforts to locate a student, one of our district attendance officers will join the effort to locate the student/parent and reconnect them with an educational opportunity.
