Instructional Bills



#### HB 900: READERS Act

- The Texas State Library and Archives Commission, with approval by majority vote of the SBOE, will adopt standards for school library collection development policies. 9/24
- The standards adopted will be reviewed every 5 years and must prohibit harmful material, sexually explicit material, and pervasively vulgar or educationally unsuitable material.
- Library material vendors must issue appropriate ratings for sexually explicit and sexually relevant materials previously sold to school districts. 4/24
- TEA may disagree with the rating; rating changed.
- Vendors may not sell any books with sexually explicit content moving forward and must report list to TEA of books already sold to libraries.
- School districts review vendor rated sexually relevant material in their current collection and post a report on their website.1/25

#### HB 3803 Parent Election for a Child to Repeat a Course

- A parent or guardian may elect for a student in a grade up to grade 8 to repeat the grade in which the student was enrolled during the previous school year or for a student to repeat a high school course.
- For high school courses, the school district/open enrollment charter can deny if it is determined the student has met all requirements for graduation.

#### HB 1605: High Quality Curriculum

- Additional funding (on top of IMTA) provided to districts who choose to use SBOE approved materials: \$40/student. An additional \$20/student for districts printing state-owned materials (Open Educational Resources).
- Publishers must offer parent portals for instructional materials transparency.
- Local curriculum reviews are established, funded, and can be initiated via parent requests (TEA developed standards and rubric)
- Teachers cannot be required to use bi-weekly planning time to create initial instructional materials unless there is a supplemental duty agreement with the teacher (core). 24/25

- Requires the TEA to develop state-owned textbooks in certain grades & subjects, which are subject to approval by SBOE.
- SBOE must add book/word list to the ELAR TEKS
- Provides optional teacher training on stateowned textbooks for districts to utilize, and grant program to educator prep programs to support.
- ISD administrative responsibilities for reporting instructional materials use to TEA.
- Prohibits three-cueing in early literacy instruction.

#### SB 2124: Advanced Math

Automatically enroll 6th grade students in an advanced math course if:

1. performed in the top 40% on the 5th grade STAAR math assessment; or

2. on a local measure that includes class ranking or demonstrated proficiency in 5th grade math coursework.

- Requires advanced math courses (Alg 1) be offered in MS if those courses are not currently offered.
- Parents may opt their children out of this requirement.


# HB 1416: Accelerated Instruction (ie, 4545 cleanup)

- Eliminated the accelerated learning committee (ALC) requirement and clarified parental "opt-out" protocols.
- Decreased the maximum # of subjects to 2 while prioritizing RLA/math and reducing requirements to 15 hours for some students.
- Students scoring significantly below satisfactory 30 hours required.
- Increased student to tutor ratios from 3:1 to 4:1; Ratio waived with use of approved automated/online curriculum (list available in Spring 2024).
- Maintains placement w/ a designated TIA teacher to satisfy requirements.
- IEP meeting not required until natural yearly IEP



#### PROPORTIONAL DISTRICT RATINGS

The state is proposing the use of a proportionality method in which each campus contributes a "weighted amount" of their rating to the overall district rating.

The proportion is based on the total number of students served in grades 3-12.

### DISTRICT OF INNOVATION (DOI)

- Law passed by the Texas Legislature in 2015.
- Gives traditional public school districts many of the flexibilities available to open-enrollment Texas charter schools (exemptions from some laws).
- Intended to give districts more local control to suit their individual needs.
- Approximately 80% of Tx school districts have a DOI plan.
- October Board agenda item.
