#### **House Bill 3 Overview**

Mr. Hudson reviewed the highlights from HB3 that will be effective September 1, 2023:

o Under TEC 37.108(f)(9), independent school districts and charter districts must certify that

they offer 1) emergency operations plans and 2) the opportunity for site walkthroughs to the Department of Public Safety, local law enforcement, and other first responders.

- o Under TEC 37.1071 the EOP Review compliance time frame is now:
  - For initial submission, **30 calendar days** beyond TxSSC request.
  - For correcting deficiencies, 90 calendar days beyond a notice of deficiency.
    - o TEA is notified at the **30-day point**.
- On September 25, 2023, TxSSC will request the following for review:
  - Basic Plan
  - Severe Weather Annex
  - Hazardous Materials Annex
    - Train Derailment Appendix
