







Title I – Part C



- Used to enhance career and technical education programs
 - Teaches career specific skills to students
 - Integrate career and academic content areas
- Must target all student populations including:
 - Economically disadvantaged
 - English Learners
 - Pregnant teens or single parents
 - Non-traditional students (ex: female students in male-dominated career field)


Title I – Part C



District Initiatives:

- Purchase additional technology
- Purchase equipment aligned with industry standards
 - ► Example: commercial sewing machines to replace household model
 - Example: robotics/automation equipment for engineering
- Purchase instructional materials aligned with industry standards/ certification
 - ► Example: practice certification exam software
- Train instructional staff on the latest industry and/or certification standards

- Governed by the Individuals with Disabilities Education Improvement Act (IDEIA)
- ► The provision of a Free Appropriate Public Education (FAPE) is the foundation.
- Currently serving over 15,000 students

Title I – Part A: Improving the Academic Achievement of the Disadvantaged

2022-23 Funding: \$32,065,167



Title I, Part A

- Currently serving 52 elementary and middle schools.
 All served campuses operate a schoolwide Title I Program;
- Intended to increase academic achievement in reading, writing, math, and science;
- District determine which campuses are served based upon the free and reduced meal participation of campuses. In CFISD, we serve elementary and middle schools that have 50% or more students that qualify for free and reduced meals;
- Residential, not projection data, must be used;
- Campuses are selected in rank order and funds are distributed based on a per pupil formula;
- A percentage of these funds are reserved for district initiatives.

Title II – Part A



In an effort to increase student's academic achievement, Title II — Part A provides financial assistance to school districts to:

- Increase the number of highly qualified principals and assistant principals in schools
- Include professional development activities that are coordinated with other professional development activities provided through federal, state and local programs
- Improve teacher and principal quality

Title II – Part A



Districtwide Initiatives:

- Provide staff development for teachers in English/language arts and reading, math, science, social studies, and foreign language
- Provide coaching for new principals
- Funds content area coaches' salaries

Districtwide Initiatives:

- Support salaries for Bilingual/ESL Curriculum Coaches (RLA, Math, and Science), Spanish Curriculum Specialist, and ESL paraprofessionals
- Provide on-going staff development to classroom teachers and paraprofessionals
- ❖ Support Read 180 program, New Arrival Centers, and One-way dual language programs (Pre-K − 1st) with supplemental resources

ACADEMIC OVERVIEW

- Based on assessments given at the beginning, middle, and end of year, the academic needs of each student will be addressed using the methods outlined below.
- Determine student learning needs using ongoing, locally developed assessments and subsequent data analysis.
- Providing additional learning opportunities for students such as before and after school programs, extended summer school programs for all students, tutoring, and learning opportunities embedded within the school day
- Hiring of additional staff based on campus needs such as a class-size reduction teacher, content interventionist or content specialist
- Purchasing of additional supplies and materials to support learning initiatives and interventions that differentiate for the academic needs of all students
- Providing professional development for all teachers to improve student performance
- Expanding the school start/end times at all 92 campuses to facilitate interventions designed to accelerate learning

MENTAL HEALTH SUPPORT

► CFISD provides a robust set of programs to support the mental health needs of our students and staff. These supports have been accelerated since the onset of COVID-19 and additional needs that have arisen due to time away from school and learning loss. - Evidenced-based resources to support Guidance and Counseling and Psychological Services initiatives
- Interactive online program for staff to address suicide prevention and trauma-informed care
- Curriculum and training to address multiple aspects of mental health in children and youth
- Implementation of a Mental Health Intervention Team (MHIT)
 with core duties related to suicide prevention and response,
 threat prevention/threat assessment, general mental health,
 and crisis response.
